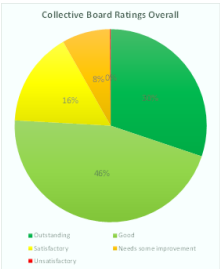
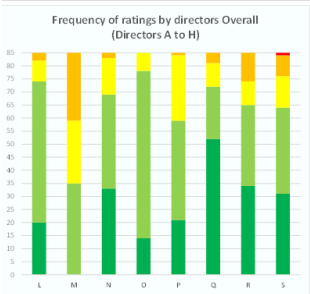
For example, an analysis of the Board Composition and Structure section is illustrated below:
